I further agree that my act of paying dues shall evidence my initial and continuing commitment to abide by the Code of Ethics, Constitutions, Bylaws, Policies and Procedures, and duty to arbitrate business disputes in accordance with the *Code of Ethics and Arbitration Manual* of the National Association of REALTORS<sup>7</sup> and the Constitution, Bylaws, and Policies and Procedures of the Cheyenne Board of REALTORS<sup>7</sup>, the Wyoming Association of REALTORS<sup>7</sup>, and the National Association of REALTORS<sup>7</sup>, as amended from time to time.

Finally, I consent and authorize the Board, through its Membership Committee or otherwise, to invite and receive information and comment about me from any Member or other person, and I agree that any information and comment furnished to the Board by any Member or other person in response to any such invitation shall be conclusively deemed to be privileged and not form the basis of any action by me for slander, libel, or defamation of character.

I understand that the Cheyenne Board of REALTORS<sup>7</sup> will maintain a membership file of information which may be shared with other boards/associations where I subsequently seek membership. This file

shall include: previous applications for membership; all final findings of Code of Ethics violations and violations of other membership duties; pending complaints alleging violations of the Code of Ethics or alleging violations of other membership duties; incomplete or pending disciplinary measures; pending arbitration requests; and information related to unpaid arbitration awards or unpaid financial obligations to the board/association or its MLS.

I understand that if accepted as a Member and I resign or am expelled from membership in the Board with an ethics complaint or arbitration request pending, the Board of Directors may condition renewal of membership upon my verification that I will submit to the pending ethics or arbitration proceeding and will abide by the decision of the Hearing Panel; or if I resign or am expelled from membership without having complied with an award in arbitration, the Board of Directors may condition renewal of membership upon my payment of the award, plus any costs that have been established previously as due and payable in relation thereto, provided that the award and such costs have not, in the interim, been otherwise satisfied.

Dues payments to the **Cheyenne Board of REALTORS<sup>7</sup>** are not tax deductible as charitable contributions. Portions of such payments may be tax deductible as ordinary and necessary business expenses.
